The Unsightly Premises Bylaw 619/17 states:

(j) 'Nuisance' means

an offensive, annoying, unpleasant or obnoxious thing, object or practice that causes an intrusion or disturbance of a visual or sensory nature affecting another person's quiet enjoyment of his or her property.

(iii) Conditions in, on, or around Property that constitute a Nuisance shall include, but not be limited to:

B) the presence of Abandoned Vehicles and Abandoned Equipment;

G) the presence of excavations, structures, materials or any other hazard or condition which poses a danger to public safety

If you need assistance in removing these unwanted vehicles please contact your local wrecker.
