## BYLAW NO. 635/18-Tax

### A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF BAWLF FOR THE 2018 TAXATION YEAR

**Whereas**, the Village of Bawlf has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the Special Council meeting held on March 28<sup>th</sup>, 2018; and

**Whereas**, the estimated municipal expenditures and transfers set out in the budget for the Village of Bawlf for 2018 total \$474,282; and

**Whereas**, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$178,758, and the balance of \$295,612 is to be raised by general municipal taxation; and

**Whereas**, the requisitions are:

Alberta School Foundation Fund (ASFF)	
Residential/Farmland	\$77,664
Non-residential	\$11,074

Total School Requisitions	\$88,738

**Whereas**, the Council of the Village of Bawlf is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**Whereas**, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

**Whereas**, the assessed value of all property in the Village of Bawlf as shown on the assessment roll is:

Residential & Farmland	\$29,671,880
Sanden Court (Municipal only)	\$ 595,760
Non-residential	<u>\$ 3,078,810</u>
	\$33,346,450

**NOW THEREFORE** under the authority of the Municipal Government Act, the Council of the Village of Bawlf, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Bawlf:

<b>Residential/Farm land</b>	\$77,664	\$29,671,880	0.002617
<b>Non-residential</b>	\$11,074	\$ 3,078,810	0.004006

3. That this bylaw shall take effect on the date of the third and final reading.
