Village Office Hours Extension

BACKGROUND/PROPOSAL:

Administration has been contemplating approaching Council about extending the office hours.

With the current amount of work load as well as numerous new requirements that will be implemented in the amended MGA this year, I would like to suggest that the Village Office also be open on the first Thursday of each month.

This extra day will allow for all month end procedures, Utility maintenance and billing and new procedures to continue to be completed in a timely manner by the appropriate staff.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

There would be two employees working this extra day, myself included. My goal is to also be able to start training/moving some responsibilities from my desk to up front which in turn will allow for myself to not work as many extra hours as I currently do. The extra day through the spring, summer and fall will also assist with staff shortages as well as can benefit the residents around tax time.

COSTS/SOURCE OF FUNDING (if applicable)

The added expenditure for the year would be approximately \$4,900 in payroll expenses plus the extra day of lights, etc.
